The Company expects to fully repay this debt, via instalments using \$US generated from oil sales, on or before 31 December 2024.</p> <p>In terms of available short-term funding: as at 31 December 2022, the Company had ~\$US6.4m* available to it under its 2017 Funding Agreement with Waterford Finance & Investment Limited (Waterford). The Company has not drawn down on this funding facility since January 2022 and intends to remain self funded going forward.</p> <p>Waterford has agreed that this funding facility can still be accessed on the understanding that any amount drawn down, post 21 December 2022, is repaid in priority to the ~\$US16.57m of balance sheet debt.</p> <p>*Given the current geopolitical environment there may be some uncertainty as to whether this undrawn amount is readily available.</p>
